January 6, 2016

The Cherry County Board of Commissioners met in regular session on January 6, 2016, as per notice in the Valentine Midland News, with the agenda being on file in the office of the County Clerk. Roll call was taken; present at this meeting were County Commissioners: Jim Van Winkle, Mark Adamson, and Tanya Storer. Also present was Cherry County Clerk, Tom Elliott.

It was the consensus of the Board to allow Chairman Adamson to conduct the meeting until reorganization. The meeting was called to order at 10:00 AM by Chairman Adamson. The Open Meetings Act Notice was announced by Chairman Adamson. The minutes of the last regular meeting were read. Commissioner Storer moved to approve minutes as read. Commissioner Van Winkle seconded the motion. Roll call vote was taken. Commissioner Adamson-aye. Commissioner Van Winkle-aye. Commissioner Storer-aye. The motion carried.

The minutes of the meeting of The Board of Corrections held December 29, 2015 were read. Commissioner Adamson moved to approve the minutes as read with the addition of discussion that took place regarding developing protocol for accepting or denying inmates from arresting agencies. Commissioner Van Winkle seconded the motion. Roll call vote was taken. Commissioner Storeraye. Commissioner Van Winkle-aye. Commissioner Adamson-aye. The motion carried.

The Gabe Doney agenda item was cancelled at Mr. Doney's request.

The Board conducted the Annual Reorganization Meeting. Commissioner Storer moved to reelect Commissioner Adamson as the Chairman of the Board for 2016. Commissioner Van Winkle seconded the motion. Roll call vote was taken. Commissioner Van Winkle-aye. Commissioner Storer-aye. Commissioner Adamson-abstain. The motion carried.

Commissioner Adamson moved to reappoint the following: Keya Paha/Cherry County Housing Authority Board – Commissioner Adamson, Region IV/Northstar Development Board – Commissioner Van Winkle, Region 4/Behavioral Health System Board – Commissioner Storer, County Welfare Chairman – Commissioner Van Winkle, RC&D Board – Commissioner Van Winkle, Road District #1 Supervisor – Commissioner Van Winkle, Road District #2 Supervisor – Commissioner Adamson, Road District #3 Supervisor – Commissioner Storer, Cherry County Highway Superintendent – Lloyd Smith, Niobrara Council – Commissioner Storer, Northwest Community Action Board – Commissioner Adamson, North Central District Health Department – Commissioner Storer, Region 24 Emergency Management Board – Commissioner Adamson, and CNEDD Board – Commissioner Van Winkle. Commissioner Storer seconded the motion. Roll call vote was taken. Commissioner Van Winkle-aye. Commissioner Storer-aye. Commissioner Adamson-aye. The motion carried.

Commissioner Storer moved that the following banks be used by the Cherry County Treasurer as depositories for County funds, as long as adequate funds are pledged to secure deposits, and to authorize the Cherry County Treasurer to invest County funds in accounts, such as CDs, for the benefit of the County: Bank of the West, Union Bank & Trust, Security First Bank, Wells Fargo Bank, NPAIT, and Pinnacle Bank. Commissioner Adamson seconded the motion. Roll call vote was taken. Commissioner Van Winkle-aye. Commissioner Adamson-aye. Commissioner Storer-aye. The motion carried.

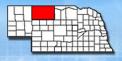

Bill Rahder and Gary Weaver reviewed a quote from Applied Connective Technologies regarding the County's phone system.

Ryan Theiss, Spencer Thomas, and Ray Meyer provided the Board with an update on the County's health insurance plan. The Board reviewed wages and salaries for county employees for 2016. It was the consensus of the Board that written payroll change notice forms be used by all County departments beginning January 2016.

The Board reviewed the fee report from the Clerk of the District Court for the month of December.

The Board reviewed the Sheriff's fee report for the period October 1 through December 31, 2015.
